### **Individual Debt Restructuring in Hong Kong**

In this webinar, Mr. Alan Cheung, principal of restructuring services of Wing United CPA Limited, who have over 20 years of experiences in handling debt restructuring for individuals, will introduce alternatives to bankruptcy such as Debt Relief Plan (DRP) and Individual Voluntary Arrangement (IVA) in Hong Kong. He will also share his experiences of the differences of handling debt restructurings from SARS in 2003, Financial Tsunami in 2008 and COVID-19 in 2020.
